Objectives and investment policy

Objectives

The objective of this fund is to achieve above-market performance, while applying an defensive asset allocation strategy. The share class is accumulating.

Investment policy

The fund gains exposure, directly or through other funds, to bonds of companies that meet certain sustainable investment criteria. With these other funds, sustainable investment criteria are applied at either the securities selection or index construction level.


In addition to the sustainable investment policy that apply to all funds in the SICAV, this fund does not invest in companies whose revenues mainly originate from sectors such as tobacco or pornography. The fund may gain exposure to any credit quality, sector and country.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 3 years.


