Objectives

The objective of this fund is to achieve above-market performance. The share class is accumulating.

Investment policy

The fund invests mainly in equities in companies with domicile or with main activity in Russia and listed on a regulated market. The fund invests also in equities in companies with domicile or with main activity in states of the former Soviet Union.

In actively managing the fund's portfolio, the management team

selects securities that appear to offer superior investment characteristics.

The fund may use derivatives for hedging and efficient portfolio management.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 7 years.
