Objectives and investment policy

Objectives

The objective of the Fund's investment activity will be to achieve value increase in the long term by diversifying the assets in compliance with the Finnish Mutual Funds Act and the Fund's Regulations.

Investment policy

The assets are invested in publicly traded equities and equity-linked securities issued mainly by North American technology companies. Technology companies are mainly companies operating in the telecommunications, information technology, bio technology, electronics and communications technology sectors. The Fund has a passive investment strategy which means that the investment breakdown seeks to follow benchmark weights for the companies in question. In addition to direct investments in equities, the Fund may invest in derivative instruments to attain an equity market risk that is in line with the benchmark.
