Objectives and investment policy

Objectives

The objective of this fund is to achieve above-market performance. The share class is accumulating.

Investment policy

The fund invests mainly in Swedish bonds.

Specifically, the fund invests at least two-thirds of net assets in bonds and other debt instruments that are traded on a regulated market, and are issued by companies, governments, municipalities or public organisations.

In actively managing the fund's portfolio, the management team

selects securities that appear to offer superior investment characteristics. The fund generally expects that its holdings, and therefore its performance, may closely resemble those of the benchmark.

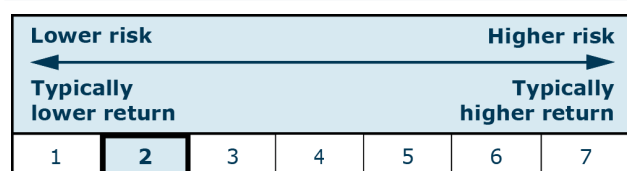
The fund may use derivatives for hedging and efficient portfolio management.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 3 years.

Risk and reward profile

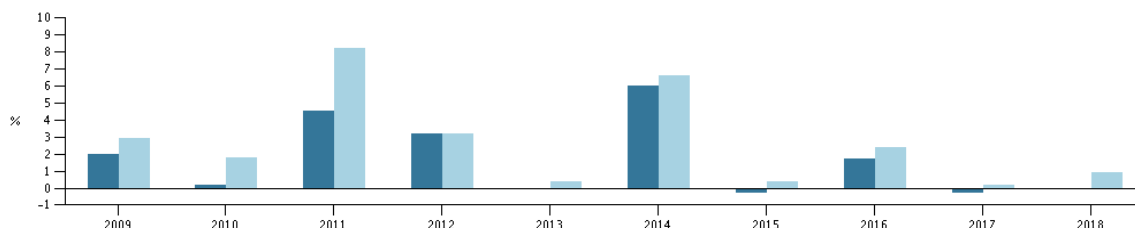
