Investment policy

The fund gains exposure, directly or through other funds, to bonds of companies that meet certain sustainable investment criteria. The fund invests only in underlying funds that apply sustainable investment criteria at either the securities selection or index construction level.

In addition to the sustainable investment policy that applies to all funds in the SICAV, this fund does not invest in bonds issued by companies whose revenues mainly originate from sectors such as tobacco or pornography. The fund may gain exposure to any credit
