Objectives and investment policy

Objectives

The objective of this fund is to achieve performance that is at least equal to that of medium-term Danish bonds. The share class is accumulating.

Investment policy

The fund invests mainly in highly rated investment grade Danish bonds.

Specifically, the fund invests at least two-thirds of net assets in bonds (including covered bonds) that are traded on a regulated market and are issued by companies, credit institutions, government, municipalities and other public organisations. These securities are denominated in DKK.

The fund may invest up to 20% of net assets in securities denominated in EUR, SEK and NOK.

The total modified duration, including cash and the adjustment for estimated premature redemption risk, is 2 to 5 years.

In actively managing the fund's portfolio, the management team selects securities that appear to offer superior investment characteristics

The fund may use derivatives for hedging and efficient portfolio management.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 3 years.
