This fund is managed by Danske Invest Management Company, part of the Danske Bank group.

Objectives and investment policy

Objectives

The objective of this fund is to achieve above-market performance. The share class is accumulating.

Investment policy

The fund invests mainly in government bonds and corporate bonds in Emerging Market countries traded on a regulated market. Corporate bonds may not exceed 30% of the fund assets.

Up to 15% of the net assets may be invested in bonds with rating of CCC or lower.

In actively managing the fund's portfolio, the management team selects securities that appear to offer superior investment characteristics.

The fund may use derivatives for hedging and efficient portfolio

management, as well as for investment purposes. The fund may take short positions through derivatives. The fund may use credit default swaps with or without underlying assets.

The total duration of the fund, including cash holding, will be the benchmark duration plus/minus 2 years.

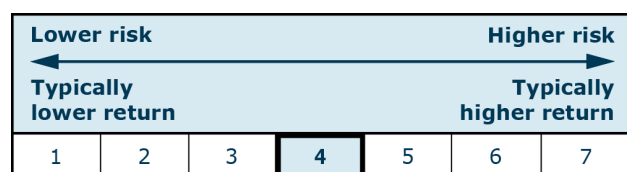
The main part of the share class' NAV will be hedged against the base currency of the fund. However, the share class remains exposed to the currencies of the investments in the fund.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 3 years.

Risk and reward profile
