This fund is managed by Danske Invest Fund Management Ltd, part of the Danske Bank group.

Objectives and investment policy

Objectives

The target of investment activities is to achieve long-term value increase on the invested assets through active asset management pursuant to the Act on Common Funds and the fund's regulations.

Investment policy

The assets are invested in publicly traded equities and equity-linked securities issued mainly by North American companies. The investment strategy is active and portfolio management will observe Danske Bank's quantitative Risk Premia Concentrated strategy. Factors predefined with statistical methods are emphasised in equity selection with typically 70 to 100 companies in the portfolio. The returns on the fund's investments, such as dividends and interest, will be reinvested.

The fund's base currency is the euro.

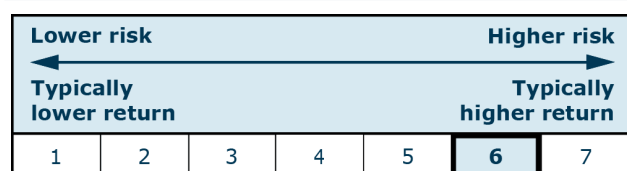
The fund is suitable for investors who seek high returns and asset value increases, while also tolerating even strong fluctuations or potential decrease in the value of the investment. The fund is suitable as part of a diversified investment portfolio. Investors may subscribe for and redeem fund units on every banking day.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Risk and reward profile



The fund is categorized as 6. The indicator illustrates the typical correlation between the risk and your potential return of the investment. The categorization is determined by the fluctuations in the fund's net asset value over the past five years and/or representative data.

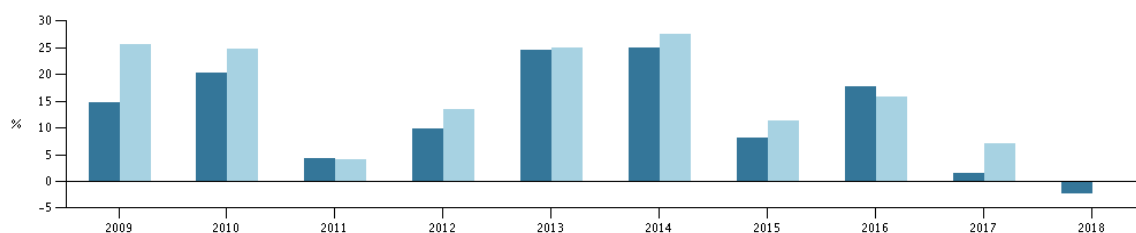

General trading terms

In contrast, the aim is that return is distributed annually on distribution units.
