Objectives and investment policy

Objectives

The target of investment activities is to achieve long-term value increase on the invested assets through active asset management pursuant to the Act on Common Funds and the fund's regulations.

Investment policy

The assets are invested mainly in euro-denominated fixed income instruments and European equities, with equity investments accounting for 25-75% of the fund's assets. Generally, half of the latter will be made in Finnish equities and half in other European equities. The issuers of fixed income investments may be both companies and governments. The returns on the fund's investments, such as dividends and interest, will be reinvested. The fund's base currency is the euro.
