# Objectives and investment policy

#### **Objectives**

The objective of this fund is to generate a return at least equal to the return on bonds from Emerging Markets. The fund is accumulating.

#### Investment policy

The fund invests mainly in government bonds and corporate bonds in Emerging Market countries. The bonds are primarily issued in USD or EUR.

The fund is actively managed. The currency risk is hedged and fluctuations in exchange rates will not affect the return.

The fund may involve a high credit risk since the fund invests in bonds with a rating lower than BBB/Baa3, i.e. bonds with low rating.

The fund generally expects that its holdings may differ significantly from those of the benchmark, e.g. in relation to issuer, credit quality, countries and duration. The fund's performance may therefore differ from the benchmark.

Fund units can normally be redeemed on banking days.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 3 years.


