## Objectives and investment policy

#### Objectives

The objective of this fund is to achieve a performance comparable to the benchmark. The share class is accumulating.

#### Investment policy

The fund seeks to track a global equity index. Specifically, the fund invests in equities and equity-related securities that are traded on a regulated market. The anticipated tracking error is 1% maximum (not quaranteed).

In passively managing the fund's portfolio, the portfolio management team invests directly in a selection of equities included in the benchmark, using a multi-factor model designed to reduce trading costs and minimise tracking error.

Tracking error is a measure of the difference of returns between the fund and its benchmark.

The fund may use derivatives for hedging and efficient portfolio management, as well as for investment purposes.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

MSCI World Index (net dividends reinvested) converted to SEK.


