## Objectives and investment policy

#### Objectives

The objective of this fund is to achieve above-market performance, while applying a defensive-to-balanced asset allocation strategy. The share class is accumulating.

#### Investment policy

The fund gains exposure, directly or through other funds, to bonds and equities. The fund generally expects to place an emphasis on bonds. The fund only invests in underlying funds where ESG-related processes or criteria are applied. The fund may gain exposure to any credit quality, sector and country, including emerging markets.

Specifically, the fund's default asset allocation is 70% in bonds and 30% in equities, but this may be adjusted depending on the investment manager's market outlook.

The fund restricts certain sectors, companies, products, or activities from the investment universe. Material ESG issues are addressed and promoted through active ownership.

In actively managing the fund's portfolio, the management team applies a flexible asset allocation that seeks to take full advantage of

market changes and opportunities.

The fund generally expects that its holdings and, therefore its performance, may differ significantly from those of the benchmark.

The fund may use derivatives for hedging and efficient portfolio management, as well as for investment purposes.

The fund may invest in Chinese A-shares subject to quota and operational constraints, which may increase legal and counterparty risk

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 3 years.

60% OMRX Total Market Index, 18% MSCI AC World (net dividends reinvested), 12% SIX Portfolio Return Index (gross dividends reinvested), 5% Bloomberg-Barclays Euro-Agg 500MM Corp A-BBB (hedged into SEK) and 5% JPM EMBI Global Diversified (hedged into SEK).


