## Objectives and investment policy

#### Objectives

The objective of this fund is to achieve above-market performance, while contributing to a climate-resilient economy. The share class is accumulating.

#### Investment policy

The fund seeks to track a global equity index.

The management team invests directly in a selection of equities included in the benchmark using a multi-factor model that minimises the tracking error while also reducing trading costs.

The fund is categorised as article 9 under SFDR and has a sustainable investment objective as attained through a designated reference index. In addition, the fund promotes environmental and/or social characteristics through screening, restrictions as well as active ownership. The fund follows Danske Invest's responsible investment policy.

In passively managing the fund's portfolio, the portfolio management team invests directly in a selection of equities included in the benchmark, using a multi-factor model designed to reduce trading costs and minimise tracking error.

Tracking error is a measure of the difference of returns between the fund and its benchmark.

The fund may use derivatives for hedging and efficient portfolio management, as well as for investment purposes.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

MSCI World Index (net dividends reinvested) (converted into the respective share class currency).


