
Objectives

Investment policy

The fund gains exposure, directly or through other funds, to equities. The fund may use derivatives for hedging and efficient portfolio management, as well as for investment purposes. The fund may invest in Chinese A-shares subject to quota and operational constraints, which may increase legal and counterparty risk. 
