Objectives and investment policy

Objectives

The objective of this fund is to achieve long-term investment growth, while applying a balanced-to-opportunistic asset allocation strategy. The fund is accumulating.

Investment policy

The fund invests globally in bonds and equities through open-ended UCITS ETFs and Index UCITS funds.

Screening in accordance with the RI (Responsible Investments) policy of the fund does not apply to this fund's investments.

The fund invests indirectly in both bonds and equities with a strategic allocation of 20% in bonds and 80% in equities. The actual allocation will vary from this strategic allocation. The allocation to equities shall

as a minimum be 50% and the allocation to bonds must not exceed 50%.

The modified duration of the fund's investments in bonds, including cash holdings, must be at least 3 years.

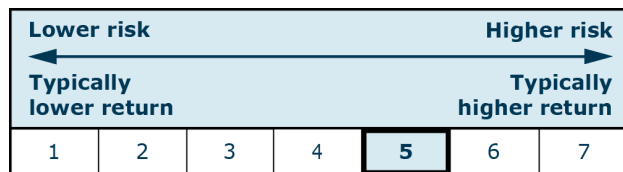
At least 90% of the fund's investments in bonds must be denominated in or hedged to EUR.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 3 years.

Benchmark

The fund has no benchmark.

Risk and reward profile



The fund is categorized as 5. The indicator illustrates the typical correlation between the risk and your potential return of the investment. The categorization is determined by the fluctuations in the fund's net asset value over the past five years and/or representative data.

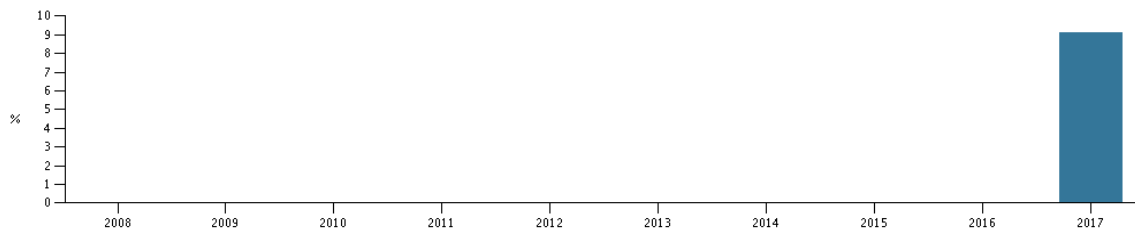
