Objectives and investment policy

Objectives

The objective of this fund is to generate a return at least equal to the return on small companies in the emerging markets. The fund is accumulating.

Investment policy

The fund invests in equities in small and medium sized companies domiciled in or with major activities in the emerging markets and listed on an official stock exchange.

The investment strategy is active. This means that we aim to find the best investments to generate the highest possible return with due consideration to risk. The strategy implies that the investments in the portfolio may deviate from the benchmark, and that returns can be

either higher or lower than the benchmark.

The fund may invest in Chinese A-shares through the Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect Programmes which are subject to quota limitations and operational constraints such as local custody requirements which may result in increased legal and counterparty risk.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 7 years.


