This fund is managed by Danske Invest Management Company, part of the Danske Bank group.

Objectives and investment policy

Objectives

The objective of this fund is to achieve long-term investment growth, while applying a defensive-to-balanced asset allocation strategy. The share class is accumulating.

Investment policy

The fund invests globally in bonds and equities through exchange-traded funds (ETF) and index-tracking funds.

Screening in accordance with the RI (Responsible Investments) policy of the fund does not apply to this fund's investments.

The fund may gain exposure to any credit quality, sector and country, including emerging markets.

The fund invests indirectly in both bonds and equities with a strategic allocation of 75% in bonds and 25% in equities. The actual allocation will vary from this strategic allocation. The allocation to bonds shall as a minimum be 60% and must not exceed 85%. The allocation to equities shall as a minimum be 15% and must not exceed 40%.

The total duration of the fund's investments in bonds, including cash holdings, must not exceed 3 years.

At least 90% of the fund's investments in bonds must be denominated in or hedged to EUR. However, currency risk can still arise from any non-EUR debt securities held by underlying funds.

In actively managing the fund's portfolio, the management team applies a flexible asset allocation that seeks to take full advantage of market changes and opportunities.

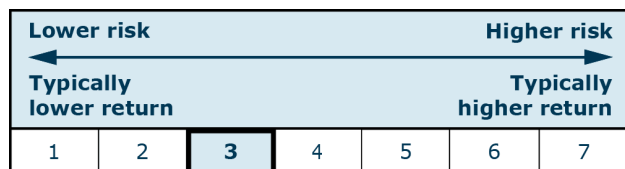
The fund may use derivatives for hedging and efficient portfolio management.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 3 years.

Benchmark

The fund has no benchmark.

Risk and reward profile



The fund is categorized as 3. The indicator illustrates the typical correlation between the risk and your potential return of the investment. The categorization is determined by the fluctuations in the fund's net asset value over the past five years and/or representative data.

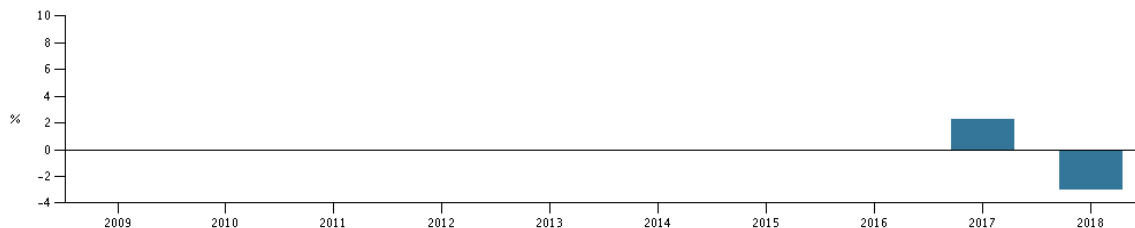
