Objectives and investment policy

Objectives

The objective of this fund is to achieve long-term investment growth, while applying a balanced asset allocation strategy. The share class is accumulating.

Investment policy

The fund invests globally in bonds and equities through exchange-traded funds (ETF) and index-tracking funds. The fund may gain exposure to any credit quality, sector and country, including emerging markets.

Screening in accordance with the sustainable investment policy of the fund does not apply to this fund's investments.

Specifically, the fund's default asset allocation is 65% in bonds and 35% in equities, but this may be adjusted depending on the investment manager's market outlook.

The total average duration of the fund's investments in bonds, including cash holdings, must be at least 3 years.

At least 90% of the fund's investments in bonds must be denominated in or hedged to EUR.

In actively managing the fund's portfolio, the management team applies a flexible asset allocation that seeks to take full advantage of market changes and opportunities.

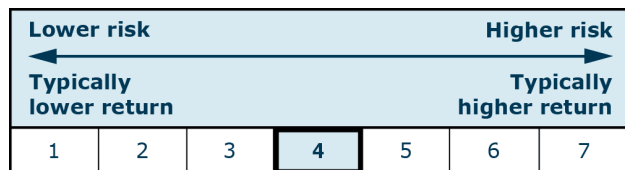
The fund may use derivatives for hedging and efficient portfolio management.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 3 years.

Benchmark

The fund has no benchmark.

Risk and reward profile



The fund is categorized as 4. The indicator illustrates the typical correlation between the risk and your potential return of the investment. The categorization is determined by the fluctuations in the fund's net asset value over the past five years and/or representative data.

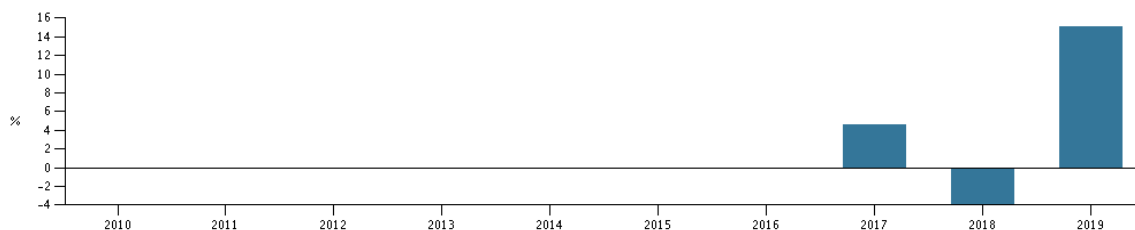
