## Objectives and investment policy

### Objectives

The objective of this fund is to generate a return at least equal to the return on small companies in the emerging markets. The fund is accumulating.

### Investment policy

The fund invests in equities in small and medium sized companies domiciled in or with major activities in the emerging markets and listed on an official stock exchange.

The investment strategy is active. This means that we aim to find the

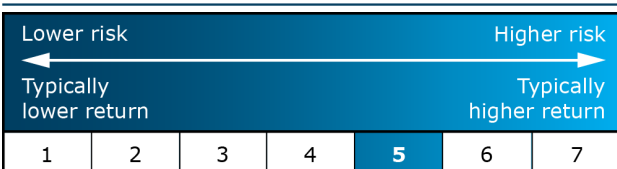
best investments to generate the highest possible return with due consideration to risk. The strategy implies that the investments in the portfolio may deviate from the benchmark, and that returns can be either higher or lower than the benchmark.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 10 years.

## Risk and reward profile



The fund is categorized as 5. The indicator illustrates the typical correlation between the risk and your potential return of the investment. The categorization is determined by the fluctuations in the fund's net asset value over the past five years and/or representative data.

## Charges

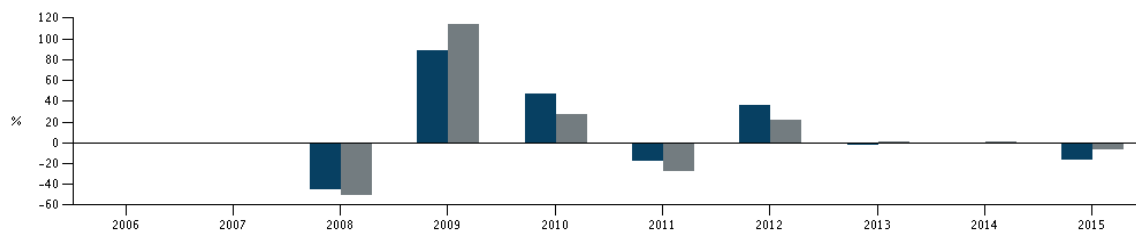
