This fund is managed by Danske Invest Management A/S, a subsidiary of Danske Bank A/S.

Objectives and investment policy

Objectives

The objective of this fund is to achieve long-term investment growth, while applying a defensive-to-balanced asset allocation strategy. The share class is accumulating.

Investment policy

The fund gains exposure to bonds and equities, with emphasis on bonds, by investing in other funds such as exchange-traded funds (ETFs) and index-tracking funds. The fund mainly invests in underlying funds where ESG-related processes or criteria are applied (although these funds do not necessarily promote ESG characteristics). The fund may gain exposure to any credit quality, sector and country, including emerging markets.

Specifically, the fund's default asset allocation is 80% in bonds and 20% in equities, but this may be adjusted depending on the investment manager's market outlook.

The allocation to bonds and other debt instruments shall be 60% to

100% and the allocation to equities 0% to 40%.

The fund adheres to the Responsible Investment Policy of Danske Bank and restricts certain sectors and companies from its investment universe.

In actively managing the fund's portfolio, the management team applies a flexible asset allocation that seeks to take full advantage of market changes and opportunities.


The fund may use derivatives for hedging and efficient portfolio management.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 3 years.

Benchmark

The fund has no benchmark.

Risk and reward profile



The fund is categorized as 3. The indicator illustrates the typical correlation between the risk and your potential return of the investment. The categorization is determined by the fluctuations in the fund's net asset value over the past five years and/or representative data.


