Objectives

The target of investment activities is to achieve long-term value increase on the invested assets through active asset management pursuant to the Act on Common Funds and the fund's regulations.

Investment policy

The assets are invested in a diversified manner mainly in publicly listed equities and equity-linked securities of companies that are Russian, operate in Russia or elsewhere in the former USSR region, are listed in Russia or elsewhere in the former USSR region, or are highly dependent on the economies of Russia or elsewhere in the former USSR region. The fund is categorized under SFDR as article 8 and promotes environmental and social characteristics, as well as good governance practices, through screening, restrictions, investment analysis and decision-making as well as active ownership.
